robert penn warren randall jarrell and robert lowell maintained lifelong well documented friendships with one another often discussing each other s work in private correspondence and published reviews joan romano shifflett s warren jarrell and lowell collaboration in the reshaping of american poetry traces the artistic and personal connections between the three writers her study uncovers the significance of their parallel literary development and reevaluates dominant views of how american poetry evolved during the mid twentieth century familiar accounts of literary history most prominently the celebration of lowell s life studies as a revolutionary breakthrough into confessional poetry have obscured the significance of the deep connections that lowell shared with warren and jarrell they all became quite close in the 1930s with the content and style of their early poetry revealing the impact of their mentors john crowe ransom and allen tate whose aesthetics the three would ultimately modify and transform the three poets achieved professional maturity and success in the 1940s during which time they relied on one another s honest critiques as they experimented with changes in subject matter and modes of expression shifflett shows that their works of the late 1940s were heavily influenced by robert frost this period found warren jarrell and lowell infusing ostensibly simple verse with multifaceted layers of meaning capturing the language of speech in diction and rhythm and striving to raise human experience to a universal level during the 1950s the three poets became public figures producing major works that addressed the nation s postwar need to reconnect with humanity warren jarrell and lowell continued to respond in interlocking ways throughout the 1960s with each writer using innovative stylistic techniques to create a colloquy with readers that directed attention away from superficial matters and toward the important work of self reflection drawing from biographical materials and correspondence along with detailed readings of many poems warren jarrell and lowell offers a compelling new perspective on the shaping of twentieth century american poetry

become one of the early twentieth century's most celebrated writers as a staff reporter for the *New York World* and *Saturday Evening Post* he became one of the highest paid journalists in the United States he also wrote short stories for noted magazines published books and penned scripts for the stage and screen in *Irvin S. Cobb: The Rise and Fall of a Southern Humorist* historian William E. Ellis examines the life of this significant writer though a consummate wordsmith and a talented observer of the comical in everyday life Cobb was a product of the reconstruction era and the Jim Crow South as a party to the endemic racism of his time he often bemoaned the North's harsh treatment of the South and stereotyped African Americans in his writings marred by racist undertones Cobb's work has largely slipped into obscurity nevertheless Ellis argues that Cobb's life and works are worthy of more detailed study citing his wide ranging contributions to media culture and his coverage of some of the biggest stories of his day including on the ground reporting during World War I a valuable resource for students of journalism American humor and popular culture this illuminating biography explores Cobb's life and his influence on early twentieth century letters

Montgomery and Mazo de la Roche whose stories and novels appeared serially and kept readers and publishers in a state of anticipation each author answered through the writing and dissemination of further instalments McClung's *Pearlie Watson* trilogy 1908-1921 Montgomery's *Anne of Green Gables* books 1908-1939 and de la Roche's *Jalna* novels 1927-1960 were read avidly not just as sequels but as serials in popular and literary newspapers and magazines a number of the books were also adapted to stage film and television the next instalment argues that these three Canadian women writers all born in the same decade of the late nineteenth century were influenced by early twentieth century publication marketing and reading practices to become heavily invested in the cultural phenomenon of the continuing story a close look at their serials sequels and adaptations reveals that rather than existing as separate cultural productions each is part of a cultural and material continuum that encourages repeated consumption through development and extension of the originary story this work considers the effects that each mode of dissemination of a narrative has on the other

edith wharton and willa cather wrote many of the most enduring american novels from the first half of the twentieth century including wharton's *The House of Mirth* *Ethan Frome* and *The Age of Innocence* and cather's *My Ántonia* *Death Comes for the Archbishop* yet despite their perennial popularity and their status as major american novelists wharton 1862 1937 and cather 1873 1947 have rarely been studied together indeed critics and scholars seem to have conspired to keep them at a distance wharton is seen as our literary aristocrat an author who chronicles the lives of the east coast europe bound elite while cather is considered a prairie populist who describes the lives of rugged western pioneers these depictions though partially valid nonetheless rely on oversimplifications and neglect the striking and important ways the works of these two authors intersect the first comparative study of edith wharton and willa cather in thirty years this book combines biographical historical and literary analyses with a focus on place and aesthetics to reveal wharton's and cather's parallel experiences of dislocation their relationship to each other as writers and the profound similarities in their theories of fiction julie olin ammentorp provides a new assessment of the affinities between wharton and cather by exploring the importance of literary and geographic place in their lives and works including the role of new york city the american west france and travel in doing so she reveals the two authors shared concern about the culture of place and the place of culture in the united states

anaïs nin made her reputation through publication of her edited diaries and the carefully constructed persona they presented it was not until decades later when the diaries were published in their unexpurgated form that the world began to learn the full details of nin's fascinating life and the emotional and literary high wire acts she committed both in documenting it and in defying the mores of 1950s america trapeze begins where the previous volume *Mirages* left off when nin met rupert pole the young man who became not only her lover but later her husband in a bigamous marriage it marks the start of what nin came to call her trapeze life swinging between her longtime husband hugh guiler in new york and her lover pole in california a perilous lifestyle she continued until her death in 1977 today what nin did seems impossible and what she sought perhaps was impossible to find harmony and completeness within a split existence it is a story of daring and genius love and pain largely unknown until now
